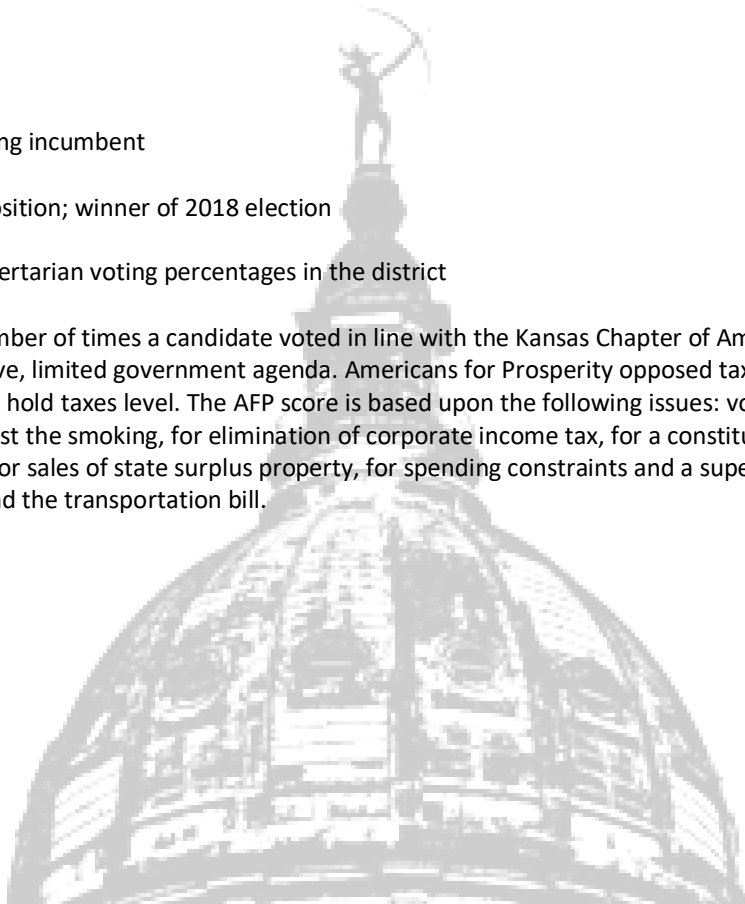

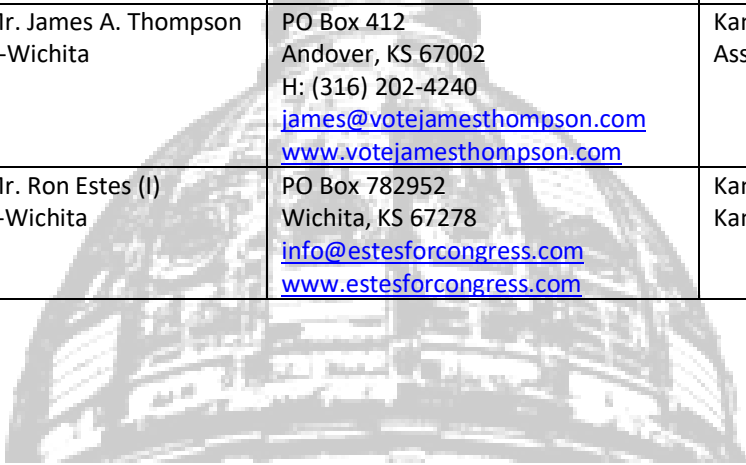

AFP Score % - based on the number of times a candidate voted in line with the Kansas Chapter of Americans for Prosperity. The AFP represents a fiscally conservative, limited government agenda. Americans for Prosperity opposed tax increases and sought further cuts in spending by the state to hold taxes level. The AFP score is based upon the following issues: voting for a streamlining government commission, against the smoking, for elimination of corporate income tax, for a constitutional amendment to opt out of federal healthcare legislation, for sales of state surplus property, for spending constraints and a super majority vote to raise taxes, against the budget, sales tax and the transportation bill.



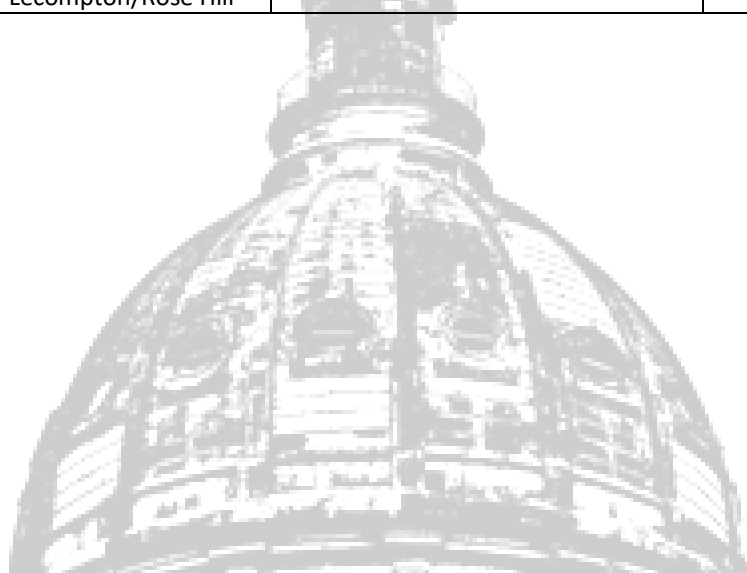
